Section 1: **WIDP Associate Guidelines**

- WIDP Associates are end users qualified to purchase WIDP web account access, administer WIDP questionnaires, and interpret profile results as well as build own client database and access ad hoc training materials offered.
- WIDP Associates have access to additional training for information and CEU purposes, if applicable.
- WIDP Associates can become WIDP Affiliates or Affiliate Managers once training requirements are met and appropriate fees are paid at desired level.
- All WIDP Associates will pay a one-time Account Activation fee.
- All WIDP Associates are required to pay \$50/mo. maintenance fee for web access and use of tool/database.

Qualifications for **WIDP Associate**



- State-licensed as therapist, psychologist, psychiatrist, or counselor OR if you are NOT any of the above, participate in the 9-hour WIDP Basic Seminar training
- Pay one-time Account Activation Fee to use the WIDP web-based software and administer/interpret profiles
- Maintain payment of monthly maintenance fee
- Purchase Profiles as desired

Section 2: **WIDP** Affiliate Guidelines

- WIDP Affiliates are end users qualified to purchase WIDP web account access, administer WIDP questionnaires, and interpret profile results as well as build own client database and access ad hoc training materials offered.
- Only WIDP Affiliates may train and certify others through conducting WIDP Basic Seminars, WIDP Advanced Seminars, using WIDP approved content and materials.
- All WIDP Affiliates will pay a one-time Account Activation fee.
- All WIDP Affiliates are required to pay \$50/mo. maintenance fee for web access and use of tool/database.

- Purchase and participate in 12-hour WIDP Advanced Seminar training
- Pay one-time Account Activation Fee (if account has not been created before) to use the WIDP web-based software and administer/interpret profiles

- WIDP Affiliate Managers are end users qualified to purchase WIDP web account access, administer WIDP questionnaires, and interpret profile results as well as build own client database and access ad hoc training materials offered.
- WIDP Affiliate Managers may train and certify others through conducting WIDP Basic Seminars, WIDP Advanced Seminars, and WIDP Instructor Training & Exam using WIDP approved content and materials.
- All WIDP Affiliate Managers will pay a one-time Account Activation fee.
- All WIDP Affiliate Managers are required to pay \$50/mo. maintenance fee for web access and use of tool/database.

Qualifications for WIDP Affiliate Manager



- Purchase and participate in 12-hour WIDP Advanced Seminar training
- Purchase and participate in 3-hour Instructor Training with Exam
- Pay one-time Account Activation Fee (if account has not been created before) to use the WIDP web-based software and administer/interpret profiles
- Maintain payment of monthly maintenance fee
- Purchase Profiles as desired

Users able to administer WIDP Questionnaire and interpret results.

WIDP AFFILIATE

Users able to administer WIDP Questionnaire and interpret results. Able to certify others and conduct training seminars using WIDP approved content and materials. Retain any seminar training fees and commission on profiles purchased.

WIDP AFFILIATE MANAGER

Trainers able to administer WIDP Questionnaire and interpret results. Able to certify others and conduct training seminars using WIDP-approved content and materials. Retain any seminar training fees and commission on profiles purchased by your onboarded WIDP account-holders.
